AGENDA ITEM #4 – OLD BUISNESS

- A. Projects Update reported by Mike K:
 - a. Covered Bridge Park Playground No new updates
 - b. Vistas Park No new updates
 - c. Kohler Ridge The township has selected Omnes to create the Kohler Ridge Park Master Plan. First public meeting will be April 22nd from 6-7:00pm.
 - d. Jordan Creek Greenway Mike K. presented the draft design and layout provided by Michael Baker. While reviewing the plan Mark A. suggested that we look to possibly move the existing entrance/exit into the butterfly garden parking lot to increase sight lines.

- g. Comprehensive Plan Mike K. stated that he has drafted the RFP and will be reviewing it internally shortly. The goal is to complete this in 2021.

- C.
