

# 2022 GOAL: Agriculture Resource Protection




#### Historic Resource Comp Plan Goals



#### Natural Resources Comp Plan Goals

NRCPG3: Evaluate appropriate protection levels for woodlands, and protection/replacement of shade trees and shade tree canopy.
