## • Background Information:

Section 530 (Vacancies in General), (a) of the First Class Township Code provides that the Board of Commissioners has thirty (30) days to appoint a successor when a vacancy occurs in the elected office of Commissioner due to termination of residency from the Township.

The office of the Township Solicitor has clarified that the vacancy in the elected office of Commissioner was technically created the day that former Commissioner, David M. Kennedy, terminated his residency, which was Thursday, November 30, 2023. The Board had thirty (30) days, which was Saturday, December 30, 2023, from said termination of residency date to appoint a successor. That deadline has now passed. In accordance with the First Class Township Code, the Vacancy Board has a deadline of January 14th to take action on the appointment of a successor.

The Board of Commissioners previously convened a special meeting on Thursday, December 28, 2023 at 6:00 PM for the following purpose(s), as advertised in accordance with the Sunshine Act in the December 27<sup>th</sup> issue of the *Lehigh Valley Press*:

- 1). To interview candidates for the vacant position of Township Commissioner;
- 2). To consider the appointment, by resolution, of a successor to fill the vacancy in the position of Township Commissioner, in accordance with the requirements of the First Class Township Code;
- 3). To consider any other business which may come before the Board of Commissioners.

Following Township social media, Township website, *Morning Call* and *Lehigh Valley News* online dissemination, South Whitehall Township received a total of eight (8) applications for the current Commissioner vacancy.

The following candidates were interviewed during the Thursday, December 28, 2023 special meeting:

Following interviews, the Board of Commissioners elected to take additional time to review the candidates given the number of applications received. Accordingly, a special meeting of the Vacancy Board was scheduled for Wednesday, January 10, 2024 at 6:00 PM. The *Morning Call* affidavit for the special meeting advertisement is attached for reference; the advertisement ran in the January 3<sup>rd</sup> issue of the *Morning Call*.

## • Options for Consideration of Possible Official Action:

The Vacancy Board, which consists of the Board of Commissioners and one (1) Chairman, who is Mr. David Torrey, may consider the filling of the vacant elected office of Township Commissioner in accordance with the relevant provisions of the First Class Township Code. A summary of the options for the consideration of the Board of Commissioners is provided as follows:

- 1. Appoint, by Resolution, a resident of the Township to fill the vacancy in the office of elected Commissioner during the Wednesday, January 10, 2024 6:00 PM Vacancy Board special meeting. Should the Vacancy Board resolve to take this action, a Resolution is listed on the agenda to allow for this official action (in accordance with the Sunshine Act). If the Vacancy Board takes this action, the selected appointee will need to fulfill the Oath of Office requirement prior to taking office (that action will not be taken during the January 10<sup>th</sup> meeting).
- 2. Should the Vacancy Board/Board of Commissioners not make the appointment before January 14<sup>th</sup>, 2024 deadline, the matter then heads to the Court of Common Pleas. The vacancies would be filled upon presentation of a petition signed by not less than fifteen (15) registered electors of the Township.

## • Vacancy Board Special Meeting Procedures:

- 1. Each member of the Board of Commissioners and Vacancy Board Chairman will be afforded the opportunity to identify a candidate who he or she wants to suggest as the appointee to the Board of Commissioners. This is intended as an opportunity for each Board member to expound on the virtues of a particular candidate.
- 2. Each member of the Board of Commissioners and Vacancy Board Chairman will then be afforded the opportunity to make a motion to nominate (and appoint by resolution) a successor to the vacant Board of Commissioners position. It is important to note that the first candidate to receive a majority vote of three (3) or more Vacancy Board members will be the person successfully appointed by the Board.

A RESOLUTION OF THE VACANCY BOARD OF SOUTH WHITEHALL TOWNSHIP, LEHIGH COUNTY, PENNSYLVANIA TO APPOINT \_\_\_\_\_ AS SUCCESSOR COMMISSIONER TO FILL VACANT SEAT OF DAVID M. KENNEDY

WHEREAS, Section 55530(a) of the First Class Township Code ("Code") provides if a vacancy occurs in the office of Township Commissioner due to a termination of residency from the Township, the Township Board of Commissioners shall fill the vacancy within thirty (30) days by appointing by resolution a registered elector of the Township in which the vacancy occurs; and WHEREAS, South Whitehall Township Board of Commissioners member David M. Kennedy terminated his residency from South Whitehall Township on Thursday, November 30, 2023;

WHEREAS, the South Whitehall Township Board of Commissioners was unable to fill

the vacancy within the (30) days as required by Section 55530(a) of the Code;

WHEREAS, pursuant to Section 55530(b) of the Code, if the Board of Commissioners is unable for any reason to fill a vacancy, then the Vacancy Board shall fill the vacancy within fifteen (15) additional days by appointing a registered elector of the Township in which the vacancy

WHEREAS, as required under §55501(a) of the Code, \_\_\_\_\_ is eligible to fill the vacancy as he is a registered elector of South Whitehall Township ("Township") and has resided in the Township continuously for over one (1) year immediately prior to his appointment; and

WHEREAS, the Township Vacancy Board desires to appoint \_\_\_\_ as successor Commissioner.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Vacancy Board hereby appoints \_\_\_\_\_ to fill the vacancy on the South Whitehall Township Board of Commissioners. Said Commissioner is appointed to serve in that role until Friday, January 2, 2026, as established by the First Class Township Code. \_\_ shall also take the required Oath of Office prior to performing the duties of Township Commissioner.
