- A. Election of Officers

- B. Keisha had a resident ask about the Fernwood walking path stating it does not loop and asking why it was constructed that way. Lynn group pulled up an aerial view of the park to show how the walking path is laid out, the drainage areas that affect where it can connect, and showed how it

- does actually loop. The Board members familiar with Fernwood also helped explain details about the walking path.
- C. Mark mentioned there were many trees down from the past storms. He has seen our Public Works Department working to get trees cleaned up. He suggested offering extended hours for Yard Waste Drop-Off after bigs storms to help residents try to get rid of fallen limbs.
- D. Lynn updated the Board on the trail construction happening at Covered Bridge, and how it will affect our summer concerts. Lynn explained the various options staff looked into, and that staff is looking to book concerts in September. One option was to have concerts at the High School practice field near the road. The Board liked this option and asked staff to look into trying to schedule a summer concert at that location. Several other location options were also discussed.
